Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Talkot Rural Municipality for **Trail Bridge Program** and the Rural Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders. Talkot Rural Municipality invites sealed bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.

3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

4. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Talkot Rural Municipality or www.bolpatra.gov.np

5. Bidding documents may be purchased from the office of Talkot Rural Municipality, Bajhang or **www.bolpatra.gov.np** by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for bid documents as mentioned in the following table and the bid document fee should be deposited in **A/C No:07900106200000 Everest Bank Limited, Talkot Branch Bajhang** until the (last date of purchase of bidding document) **(2076/07/26)** from the first date of publication of this notice.

6. Bids must be submitted through **PPMO** website www.bolpatra.gov.np/egp, no hardcopy will be accepted on or before **12:00. noon on 2076/07/27 (2019/11/13)**. Documents received after this deadline shall not be accepted.

7. Bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 on 2076/07/27 (2019/11/13)** at the Contact office of Talkot Rural Municipality, Chainpur, Bajhang. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by bid security, amounting to a **minimum of 2.5 % of the quoted Bid amount (inclusive of VAT)**, which shall be **valid for 30 days** beyond the bid validity period.

8. If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in **Everest Bank Talkot Branch Bajhang Account 07900106200003 Talkot Rural Municipality, Bajhang** and submit bank deposit voucher along with the bid.

9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.

10. Pre-Bid Meeting shall be held at the Contact office of Talkot Rural Municipality, Chainpur Bajhang on **2076/07/18(2019/11/04)**.
